

## **Process of Target Allocation for GST Accounts Assistant Job role to Affiliated Training Centres under Short Term Training Component of PMKVY 2016-20**

Goods and Services Tax (GST) is one indirect tax for the nation, which will make India one unified common market. The Goods and Services Tax (GST) is an indirect tax which replaced multiple cascading taxes levied by the central and state governments. It was launched on the midnight of 30th June 2017. Banking, Financial services and Insurance Sector Skill Council of India (BFSI SSC) has forecasted a demand for the GST Accounts Assistant Job Role, as many Small and Medium Enterprises will require assistance in filing for GST. To meet the demand forecasted by the BFSI SSC, 1 lakh candidates are to be trained under Short Term Training (STT) component of the PMKVY scheme. Due to the urgent demand for this job role, it is not feasible for affiliated training centres to be re inspected before allocation of targets. Hence to meet the forecasted demand the following process can be utilized.

- National Skill Development Corporation (NSDC) will provide the list of 4 and 5 star affiliated training centres to BFSI SSC.
- BFSI SSC will contact the Training Providers/ Training Centres (TPs/TCs) that are part of the list and gather the list of TCs who are interested in conducting training for GST Accounts Assistant
- The TPs/TCs are to provide details of the spare capacity ( Number of Classrooms, Classroom Area and number of ToT certified Trainers) that will be utilized for GST Accounts Assistant Job role to BFSI SSC
- BFSI SSC will validate the information provided by the TPs / TCs
- The infrastructure details of the training centre post validation from BFSI SSC will be forwarded to NSDC and basis this information and confirmation from BFSI SSC that the TCs will conform to the norms of PMKVY Guidelines, NSDC will allocate targets to these TCs for GST Accounts Assistant Job Role
- Below conditions to be met before initiating training by Training centre
  - Submission of letter of intent
  - Agreement to start the batches only after ToT certification of Trainers
  - Confirmation of availability of additional space (not dedicated to PMKVY Targets already provided) to conduct the GST trainings (Along with validation mail/Letter from BFSI SSC)
  - Details of space available in terms of additional/vacant classrooms with their capacity (@ 10 Sq. Ft. per candidate) and number of certified trainer available for training

Kindly note that the targets for GST Accounts Assistant will be allocated for period ending 31<sup>st</sup> March 2018. Also any training centre that has been affiliated and is rated as 4 or 5 star through SMART process, if interested in conducting training in GST Accounts Assistant Job role can initiate the process by approaching the BFSI SSC with the necessary information related to SMART and infrastructure information which will be validated by BFSI SSC before it is forwarded to NSDC for Target Allocation.
